# CHEM 101 Introduction to Chemistry: The Chemistry of Food

1. Course Description: Why are the stomach contents of calves added to milk in order to make cheese? What causes a soufflé to be so light and airy? Students will find answers to these questions and more as they dive head-first into the delicious world of culinary chemistry! Prepare your taste buds for tour de force as we visit two foodcentric European cities and deconstruct the chemistry behind local treats. Germany is known for culinary delights such as sauerkraut, pretzels, cheese, and beer. While France is known for its crepes, soufflés, baguettes, and wine. We will spend our days tasting the local fare, while learning about the ins and out of the chemistry behind the food.

## 2. Overall KIIS Program Student Learning Outcomes:

Students participating in KIIS Study Abroad programs aim to:

- 3) Explore other peoples' values and clarify their own.

In the equivalent of one, single-spaced typed page, reflect on:

How has this experience made you think – or act – differently about the world around you? Please consider the 3 SLOs discussed. Please don't consider course content in your response; instead, think beyond it, and be as specific as possible.

#### 3. Course Objectives and Specific Learning Outcomes:

- 1. Become familiar with common chemistry terms and topics: stoichiometry, atoms, molecules, gas law.
- 2. Develop an understanding of different chemical processes related to food preparation: fermentation, heat, preservatives.
- 3. Achieve an understanding of the three main macromolecules making up all food: carbohydrates, lipids, protein.
- 4. Discover how your body uses and stores food for energy.
- 5. Identify key ingredients in local cuisine and their impact on the taste/cooking/chemistry of that dish.

## 4. Major Topics covered in the Course

- What is an atom
- Stoichiometry
- Drawing chemical structures
- Acids and bases

- Carbohydrates
- Lipids
- Proteins
- Biochemistry of energy storage

**5. Fulfillment of General Education Requirement:** This course fulfills the AOI science requirement at Georgetown College, and may do the same at other universities.

### 6. Required Readings and Materials

Students are expected to purchase and read <u>before</u> the start of the trip, What Einstein Told his Cook: Kitchen Science Explained by Robert L Wolke. Presentations, quizzes, and assignment uploads will be available online for students though the CANVAS course website.

### 7. Graded Assignments

- **20% Participation/Drive:** You will be expected to participate in all activities outlined by the instructor. This includes being on time to any meeting points/lectures/excursions and being open to tasting new things. You are expected to be engaged in activities and have fun!
- **40% Food Journal:** You will maintain a daily food journal where you will record the contents of one meal that you had that day. You should include the ingredients/components of that meal and discuss the chemistry of how it affects the taste/smell/cooking of that item. Example entries will be provided.
- **30% Quizzes:** There will be online quizzes that cover the chemistry concepts we will discuss.
- **20% Infographic:** As a final project, the students will generate an infographic of their favorite meal/snack/foodstuff that consumed and present it at the airport on the day of departure.

### 8. Attendance Policy:

KIIS program participants are **expected to be punctual to and in attendance at all classes**, presentations, meetings and required excursions, and to remain with the program for the full academic period. Unexcused absences from classes and/or mandatory meetings will result in a lowering of the student's final grade, as will excessive tardiness. Multiple unexcused

absences could result in expulsion from the program. Any absence from an academic class session must be excused for medical reasons.

#### 9. Disability Accommodation:

In some cases, you may need to make arrangements for a caregiver to join you on your KIIS program, should your physician, campus disability accommodation office, or KIIS make such a recommendation or require it.
