1. Course Description:

An introduction in the study of Spanish phonetics with emphasis on practical exercises for improving students' pronunciation of Spanish. Taught in Spanish. **Prerequisites:** Completion of Intermediate Spanish

Prior to your KIIS study abroad program, and again at the conclusion of your program, KIIS will ask each student to a) answer a few multiple-choice questions, and b) write a short reflective essay (two paragraphs in length) related to the elements detailed above. There is no right or wrong answer, and your responses will not affect your grade in any way. The purpose of the exercise is to help KIIS measure the effectiveness of its study abroad programs.

3. Course Objectives and Specific Learning Outcomes:

The goal of SPAN 345 is to strengthen knowledge of the Spanish phonetic system and pronunciation by:

• providing a place for examination and practice of the sounds in Spanish in which learner articulation is both the message and the mode,

- engaging learners in activities that challenge the notion of what Spanish is and how it is articulated,
- equipping learners with the metalinguistic and metacognitive language necessary for linguistic description that reflects appropriate speech.

4. Major Topics covered in the Course:

Spanish phonetic symbols and descriptions Syllabification and accentuation The phoneme The vowels of Spanish The consonants of Spanish Dialectology - Spanish around the world

Course Methodology: Class time is mainly for directed oral practice and examination of phonemes and allophones; learners must prepare thoroughly outside class by reading assigned pages from the book, working with classmates towards internalization, marking passages that present difficulties (in order to ask the instructor/classmates for clarification), and becoming familiar with the metalinguistic vocabulary. By doing this learners prepare themselves to use their new vocabulary appropriately during oral work in class. Classes will be conducted entirely in the target language, Spanish, and although sometimes it may be frustrating, the more you are exposed to the target language, the more you will understand it. Remember that it is assumed that you will not understand or be able to respond to everything that the instructor or fellow learners say. You must be patient with yourself and try to capture as much as possible and communicate as much as possible. Communicativity, in combination with accuracy and metalinguistic discourse, is your goal when participating in our class. I will say things as many times and in as many different ways as needed for you to understand me. I don't expect flawless, fluent Spanish from you – only that you give your classmates and me your best efforts.

Feel free to ask questions in class, or to speak to me outside of class. You are not required to talk to me in Spanish in my office, but keep in mind that the purpose of your visits should not be to receive an English language version of what is done in class. While it is important for you to understand me, it is just as important for your classmates to understand you. Try to be a clear as possible and look to see if you are being understood. Studies have shown that making yourself understood by all your listeners (and not just your instructor or someone who is used to speaking with students) is essential to developing your linguistic ability.

7. Graded Assignments:

Tarea: assignments are to be done BEFORE class. No work will be accepted late. You need to have homework or any other written ready to be turned in at the beginning of the class period. Hand in your work as you enter the classroom.

Participación en clase: all learners will be expected to participate actively in all class activities in Spanish. Your speaking in Spanish rather than English, evidence that you have done the reading and assignments prior to class, cooperation in group and pair work and willingness and preparedness in answering questions and participating in discussion are factors in the grade. At the end of every week the professor will give everyone a participation grade based on the level of participation shown during the class period.

Pruebas: these pruebas may include some or all of the following elements: phonetic description, multiple choice, group work, presentations, phonetic transcriptions, etc. You may be informed ahead of time.

Exam oral: Each student will read a paragraph-length text (professor will provide copies of the text during the first week). Students will perform a preliminary reading of their selected text with the professor and will receive an assessment of their phonetic performance at the start of the course. They will meet with their professor at the mid-point of the program for additional feedback and constructive criticism of their pronunciation, and will receive an updated assessment of their phonetic performance. Throughout the term, students will work to memorize the text. At the end of the term, students will perform a final version of the reading for their professor for an exam grade. This assessment targets students' ability to accurately produce the Spanish sound system in a controlled context. Failure to arrive on time for the scheduled meeting will result in an automatic 0 and no make-ups will be allowed.

Individual bienvenida: Each student will sign up to give the Bienvenida at the beginning of class. The *Bienvenida* will take 4-5 minutes and must include the following: 1) a brief welcome to classmates, 2) the date and weather, 3) a current event in the city, state, or world, 4) some relevant aspect of the Spanish phonetic system based on your personal experience that week, 5) and a description of a problem you encountered that you were able to figure out that relates to our class. Absolutely NO note cards will be allowed.

8. Attendance Policy:
