Students participating on KIIS study abroad programs aim to:

- 1) Understand contemporary issues of their host country/countries (i.e. KIIS program location).
- 2) Develop skills to interact comfortably in a global setting.
- 3) Understand other cultures.

*Prior to your KIIS study abroad program, and again at the conclusion of your program, KIIS will ask each student to a) answer a few multiple-choice questions, and b) write a short reflective essay (two paragraphs in length) related to the elements detailed above. There is no right or wrong answer, and your responses will not affect your grade in any way. The purpose of the exercise is to help KIIS measure the effectiveness of its study abroad programs.*

**Course Objectives and Specific Learning Outcomes:** This course is designed to provide students with a critical understanding of Spanish history and culture, and foster an appreciation for contemporary Spain's issues and idiosyncrasies. The course will combine history with a focus on contemporary Spain: its nationalisms, economy, society, and popular culture. Our approach will be based on information from the text, sites we will visit, and other forms of media (art,

newspapers, etc.), presentations, and class discussion. Given the broad scope of material to be covered, the format will vary from class to class and we will emphasize essential concepts related to the specific periods.

**Required Reading and Materials:** Ugarte, Francisco, Michael Ugarte, and Kathleen McNerney. *España y su civilización*. Boston: McGraw-Hill, 2009 (**sixth edition**, ISBN 978-0-07-338520-4) Articles from Spanish newspapers and others in a pdf available through MyKIIS (make copies or download them to whatever device you are planning to use in Segovia; **you will need to have access to them in class when they are assigned**).

Students should plan to visit the Prado, the Reina Sofía, etc. on their own. Although the entrance fees are waived for students with university identification, students should plan for some expenses associated with spending the day in Madrid (around 20 euros).

**Resources:** The class is closely linked to the experience of living abroad, and students are strongly encouraged to take advantage of the abundant opportunities for conversation and learning about Spanish history and culture. Get the most out of living with a Spanish family and the excursions, your explorations of Segovia, Madrid, and other cities, read newspapers and magazines, and, if possible, watch TV. Students will visit museums in Madrid to see certain artworks on their own.

**Academic Integrity:** Students are expected to abide by the university's guidelines regarding academic integrity. As indicated in the undergraduate catalogue, "Students who commit any act of academic dishonesty may receive from the instructor a failing grade in that portion of the coursework in which the act is detected or a failing grade in the course without possibility of withdrawal" (27).

**Class participation (12%):** Se espera la **participación** activa de cada estudiante. Se asignará una nota de participación regularmente. Se usará **exclusivamente español** en clase. También se espera preguntas y/o intervenciones después de las presentaciones culturales, de arte y de las noticias.

**Exams (2) (50%):** Habrá dos exámenes sobre las ideas principales presentadas durante el curso que incluirán identificaciones, preguntas breves y ensayos.

**Oral cultural presentations (18%):** Cada estudiante tendrá que preparar tres **presentaciones** orales breves, 1) una sobre un artículo del periódico que elige y otra sobre un/a artista (8%) 2) una presentación sobre un tema cultural (10%).

**Short quizzes on readings (8%):** Durante el curso se administrarán **pruebas cortas** de contenido basadas en el material que se prepara para cada clase.

**Reflexiones on cultural visits, tareas (12%):** A lo largo del curso, habrá que entregar **unas reflexiones escritas** de las excursiones realizadas con el programa (Madrid, Toledo, Salamanca/Ávila). Estos ensayos breves tienen como objetivo expresar observaciones críticas de la visita y su extensión será como mínimo unas 250 palabras.

**Attendance Policy:** KIIS program participants are expected to be punctual to and in attendance at all classes, presentations, meetings and required excursions, and to remain with the program for the full academic period. Unexcused absences from classes and/or mandatory meetings will result in a lowering of the student's final grade, as will excessive tardiness. Multiple unexcused absences could result in expulsion from the program. Any absence from an academic class session must be excused for medical reasons.
