1. Course Description:

The main goal of this advanced conversation course is to develop a greater oral fluency and cultural understanding. The course will emphasize 1) vocabulary building, 2) intensive review of problematic areas of Spanish grammar for native speakers of English, and 3) meaningful communicative tasks in the community on a variety of cultural, social, economic, and political topics. Students will examine the usage of certain vocabulary and several grammatical concepts (e.g., the subjunctive), and they will engage in reading of authentic texts and speaking activities that include discussions, interviewing the host family members, and exploring the local community. In particular, groups of students will design a variety of survey questions for the community on relevant topics and will report their findings to the class. Students will also keep journals on cultural encounters and share their reflections. The course is taught entirely in Spanish.

2. Overall KIIS Program Student Learning Outcomes:

KIIS Study Abroad Mission Statement:

KIIS provides high-quality education abroad programs for students from all diverse backgrounds that promote deep international learning, are integrated into the curriculum, and encourage critical and creative thinking. Our goal is to help students understand the wider world and develop personal and professional skills for lifelong enrichment. We strive to go beyond generalizations and cultural stereotypes to help foster a nuanced appreciation of the world in which we live.

Students participating on KIIS study abroad programs aim to:

- 1) Understand contemporary issues of their host country/countries (i.e. KIIS program location).
- 2) Develop skills to interact comfortably in a global setting.
- 3) Understand other cultures.

Prior to your KIIS study abroad program, and again at the conclusion of your program, KIIS will ask each student to a) answer a few multiple-choice questions, and b) write a short reflective essay (two paragraphs in length) related to the elements detailed above. There is no right or wrong answer, and your responses will not affect your grade in any way. The purpose of the exercise is to help KIIS measure the effectiveness of its study abroad programs.

3. Course Objectives and Specific Learning Outcomes:

After completing this course, students should be able to communicate more appropriately in Spanish in diverse social contexts:

- Engage in conversations and generate writings that provide and obtain information, express feelings and emotions, and exchange and support opinions;
- Understand and interpret written and spoken language on a variety of cultural topics;
- Present information, concepts, and ideas to an audience;
- Handle a wider range of vocabulary and demonstrate their appropriate use of idiomatic structures.

4. Required Readings and Materials:

5. Graded Assignments: Note KIS/WKU does not award +/- grades, only full letter grades. Students will demonstrate the course learning outcomes through oral interviews, presentations, quizzes, regular reading and writing assignments, and class participation. Grades will be based on the quality and quantity of oral and written production. The final grade will be based on the following:

- Class Participation and Preparation. Preparedness for each class, willingness to use Spanish in class at all times, and oral practice outside class will determine your learning outcomes for the course. The class is intimately linked to the experience of living abroad, and you are expected to take advantage of the abundant opportunities for conversation. Make an intentional effort to get to know your host family, and reciprocate the hospitality extended to you by making the home stay experience pleasant and interesting for your host family as well. **Make a self-pledge to speak only Spanish and make a pact with your roommate to do the same with him/her.** Your weekly participation grade be based on: 1) **evidence of intentional practice of Spanish outside the class;** 2) completion of all the assignments before each class (e.g., obtaining answers to survey questions for locals, learning vocabulary, refining grammar concepts covered, thoughtful reading of the assigned texts and any written homework, and so forth); 3) attendance and punctuality; 4) active class participation and use of Spanish at all times; and 5) respect for *la profesora, los compañeros*, and others you meet through the program.
- Oral Presentations/Creative Oral Projects. You will make three short presentations to the class. Each presentation will be graded based on: 1) sufficient & interesting content in Spanish, 2) quality of Spanish – variety of vocabulary and grammar, and 3) speed and pronunciation.
- Journal Entries. You will hand in several journal entries (200-300 words). These written activities will describe and evaluate the details of your weekly experience. The purpose of the journals is to assist us in sharing discoveries, reflections, needs, and plans. They will help you better connect your immersion experience with the learning objectives of the

course. You will be evaluated on completeness, depth of reflection, and quality of writing in Spanish.

- Quizzes. These brief *pruebas* (10 mins.) will be given at the beginning of the class. They are based on materials covered during previous classes and your assignments (lecturas, vocabulario, gramática...etc.). One lowest quiz grade will be dropped.
- Entrevista final. You and a classmate will prepare and carry on a 20 minute conversation that will consist of three parts: 1) give and request information and opinion on a variety of cultural topics explored during the program; 2) role play with your partner; and 3) follow-up conversation with the instructor.

6. Attendance Policy:

KIIS program participants are expected to be punctual to and in attendance at all classes, presentations, meetings and required excursions, and to remain with the program for the full academic period. Unexcused absences from classes and/or mandatory meetings will result in a lowering of the student's final grade, as will excessive tardiness. Multiple unexcused absences could result in expulsion from the program. Any absence from an academic class session must be excused for medical reasons.

7. Disability Accommodation:

KIIS will make every reasonable effort to provide accommodations for program participants with special needs or disabilities, but we cannot guarantee that we will be able to do so. Be aware that many foreign countries do not have comprehensive legislation comparable to the Americans with Disabilities Act (ADA). As a result, businesses and other establishments operating in foreign countries may not be able to provide accommodations.

Failure to notify KIIS may prevent you from participating on your KIIS program.

If you require any accommodations abroad, you must provide KIIS Assistant Director, Maria Canning, or KIIS Admissions and Enrollment Specialist, Haley McTaggart, an accommodation letter from your home campus' disability accommodation office that lists the accommodations you are eligible to receive. Please do not request accommodations directly from your KIIS Program Director or other KIIS Faculty; the KIIS Office will notify your KIIS Program Director and/or Faculty after we have received your above accommodation letter.

In some cases, you may need to make arrangements for a caregiver to join you on your KIIS program, should your physician, campus disability accommodation office, or KIIS make such a recommendation or require it.
