Course Description:

How cities and nations craft their past through public monuments, urban planning, and museum programming provides an avenue to understanding what a society deems critical at a particular moment in time. Buenos Aires has a distinct history shaped by its region and geo-political forces. Buenos Aires was established as a major port city in the 16th century. Its history has been marked by European migration, conflict with indigenous communities, and slavery. The latter two have all but been erased from view. The late 19th and early 20th centuries saw a deliberate Europeanization of the city – coming to be known as the Paris of Latin America. Italian migrants in particular have marked the city and region. Yet the presence of indigenous and black communities do mark the cultural spaces through practices such as the tango and the boleadoras. This tension exists alongside political conflicts as Argentina has a long history of strong men (caudillos), populist and nationalist movements, and dictatorships. These have left lasting marks on the city that has come to memorialize these collective traumas. The glittering city reveals a complex history through its urban space in its monuments, parks, and avenues, and through its museums, galleries, and festivals. These celebrate the modern accomplishments while choosing to uphold the memory of these traumas, so as not to forget, to honor those lost, and also for political exigencies of the present.

Buenos Aires is our classroom. We will be venturing into the city to see the chosen remnants of the past, the scars of war, the architecture of power, the developments of scale, and their museum exhibitions. Where does the represented past start and present end? What are the new explorations of civic identity and artistic production? How does the city contend with its geography? How are curators revealing the artistic present? Memory and identity are central to this class.

Prior to your KIIS study abroad program, and again at the conclusion of your program, KIIS will ask each student to a) answer a few multiple-choice questions, and b) write a short reflective essay (two paragraphs in length) related to the elements detailed above. There is no right or wrong answer, and your responses will not affect your grade in any way. The purpose of the exercise is to help KIIS measure the effectiveness of its study abroad programs.

Course Objectives and Specific Learning Outcomes:

In this class, students will:

- Examine social and cultural structures over time and space that have shaped contemporary societies in Buenos Aires
- Demonstrate an understanding of how Argentine society has evolved in diverse ways over time and space, with a specific focus on those cultural values that shape contemporary political, economic, social and environmental actions in Buenos Aires
- Understand the key temporal and spatial properties that shape modern cultures and societies in the region
- Understand artistic sources and place them into their social, political, and intellectual contexts
- Advance their visual literacy and vocabulary and use these skills in written and oral formats

Major Topics covered in the Course:

- Memory and remembrance
- Art and architectural history of Buenos Aires
- History and political events that shape the city
- Urban development, planned and unplanned
- Curatorial trends in museums and public spaces

Required Readings and Materials:

The course will use online sites such as Heilbrunn Timeline of Art History, Getty Foundation, and Khan Academies, as well as articles from JSTOT and online sources created by the city of Buenos Aires.

Written Assignments:

Writing assignments will include text analysis based on readings

Site Analysis:

Visual analysis assignments will focus upon exhibitions and monuments visited in class and program excursions

Exhibition/Monument proposal:

A proposal that will identify a museum for the exhibition or a site for a monument, present a vision for its execution, write promotional material, accompanying text, and include a model of the layout

Attendance Policy:

KIIS program participants are expected to be punctual to and in attendance at all classes, presentations, meetings and required excursions, and to remain with the program for the full academic period. Unexcused absences from classes and/or mandatory meetings will result in a lowering of the student's final grade, as will excessive tardiness. Multiple unexcused absences could result in expulsion from the program. Any absence from an academic class session must be excused for medical reasons.
