MUS 338 Topics: Harmony, Hostility, and Heresy—Music and Conflict

1. Course Description: Rising nationalism, the Roman Catholic Church, the power of the Habsburg dynasty, the riches of the Esterházy family, and Napoleon's armies all fueled the conflict that produced some of the greatest works of the 18th and 19th centuries. How was the music of the Viennese composers affected and inspired by the drama that resulted? This course examines the reflection of religious, political, cultural, and economic upheaval in the music of Western Europe, with particular focus on the choral, symphonic, and chamber works of Mozart, Haydn, Schubert, and Beethoven. In both Vienna and Salzburg students will study these masterworks while exploring the birthplaces, homes, performance spaces, and graves of the musicians who created them. They will then draw parallels with the musical responses to conflict of the past century, such as Britten's War Requiem, Bernstein's Mass, Copland's Fanfare for the Common Man, Górecki's Symphony of Sorrowful Songs, Liszt's The Battle of the Huns, and Messiaen's Quartet for the End of the Time, among others.

2. Overall KIIS Program Student Learning Outcomes:

KIIS Study Abroad Mission Statement:

Students participating on KIIS study abroad programs aim to:

- 1) Understand contemporary issues of their host country/countries (i.e. KIIS program location).
- 2) Develop skills to interact comfortably in a global setting.
- 3) Understand other cultures.

Prior to your KIIS study abroad program, and again at the conclusion of your program, KIIS will ask each student to a) answer a few multiple-choice questions, and b) write a short reflective essay (two paragraphs in length) related to the elements detailed above. There is no right or wrong answer, and your responses will not affect your grade in any way. The purpose of the exercise is to help KIIS measure the effectiveness of its study abroad programs.

- **3. Course Objectives and Specific Learning Outcomes**: Upon completion of this course, the successful student will be able to:
 - 1. Articulate ways in which the history of Austria intersects with the musical response of its populace through daily video reflections, walking tours, readings, live concerts, and podcast listenings.
 - 2. Critically assess music of a variety of genres within a musical, social, cultural, and political context through evaluations of live performance, video reflections, discussions, and written responses.
 - 3. Describe the effect of various political, religious, and social movements on the performing arts, as well as provide critical commentary on the current state of Austria's performing arts movements through written responses and class presentations.
 - 4. Conversely, describe the effect of the performing arts on various political, religious, and social movements through written responses and class presentations.
 - 5. Provide critical commentary on contemporary trends in Austria's artistic scene as well as on the current state of Austria's various political, religious, and social movements.
 - 6. Formulate critical assessments of music of any style.
- **4. Major Topics covered in the Course:** This course outlines several key areas that include evaluation of religious history, economic development, social upheaval, military conflict, and political development in Austria. These topics will connect to specific musical trends in the music of Mozart, Haydn, Schubert, Beethoven and include choral, symphonic, and chamber works. Additional topics include evaluations of conflict and musical response from 20th/21st century and contemporary composers such as Britten, Bernstein, Copland Górecki, Liszt, Messiaen, and more.
- **5. Fulfillment of General Education Requirement:** This course will satisfy a general education requirement in fine arts/music due to the nature and content. Some institutions may consider this a history general education requirement due to the in-depth focus on historical developments as related to the music of Austrian composers in times of political, social, economic, military, and religious upheaval. Though the course is designed for musicians, reading music and prior musical study is not necessary for a student to be successful in this course.

6. Required Readings and Materials:

- University Readers Custom Course Packet containing readings and musical scores, to be purchased ahead of time at www.universityreaders.com
- In lieu of not purchasing a published textbook, please plan on saving 20 EUR for admission to concerts
- Electronic device for video journals and listening playback (laptop, tablet, smart phone, etc.) all files will be downloaded before leaving the U.S.

7. Graded Assignments:

- Assigned readings & written responses drawn from readings/listenings (20%)
- Assigned in-class discussions, lectures, and student presentations (15%)
- Corresponding Video Journal (10%)- Weekly uploads to Dropbox Folder
- Field trip reports-we will have several field trips throughout the duration of the class. Students will turn in a report for each field trip (20%)
- Final student project (35%)
 - An instructional sheet with details, expectations, and guidelines will be provided to students the second week of the program. Themes and possible topics will be drawn from course readings, excursions, and student interest areas.

8. Attendance Policy:

KIIS program participants are expected to be punctual to and in attendance at all classes, presentations, meetings and required excursions, and to remain with the program for the full academic period. Unexcused absences from classes and/or mandatory meetings will result in a lowering of the student's final grade, as will excessive tardiness. Multiple unexcused absences could result in expulsion from the program. Any absence from an academic class session must be excused for medical reasons.

9. Disability Accommodation:

KIIS will make every reasonable effort to provide accommodations for program participants with special needs or disabilities, but we cannot guarantee that we will be able to do so.
