1. Course Description:

Intensive practice in speaking and writing in Spanish based on specific readings and assignments, and the student's interaction with native speakers in the international setting.

Taught fully in Spanish.

Prerequisites: Two years of college Spanish, SPA 202 or equivalent, or faculty approval.

2. Overall KIIS Program Student Learning Outcomes:

KIIS Study Abroad Mission Statement:

KIIS provides high-quality education abroad programs for students from all diverse backgrounds that promote deep international learning, are integrated into the curriculum, and encourage critical and creative thinking. Our goal is to help students understand the wider world and develop personal and professional skills for lifelong enrichment. We strive to go beyond generalizations and cultural stereotypes to help foster a nuanced appreciation of the world in which we live.

Students participating on KIIS study abroad programs aim to:

1) Understand contemporary issues of their host country/countries (i.e. KIIS program location.)

2) Develop skills to interact comfortably in a global setting.

3) Understand other cultures.

Prior to your KIIS study abroad program, and again at the conclusion of your program, KIIS will ask each student to a) answer a few multiple-choice questions, and b) write a short reflective essay (two paragraphs in length) related to the elements detailed above. There is no right or wrong answer, and your responses will not affect your grade in any way. The purpose of the exercise is to help KIIS measure the effectiveness of its study abroad programs.

3. Course Objectives and Specific Learning Outcomes:

This Spanish Conversation and Composition class is designed to increase fluency, refine grammatical proficiency, and improve communicative skills in all its forms, presentational, interpretative and interpersonal (including narrating and describing with a variety of verb tenses and complex structures). In addition to master the language, students will have the opportunity to increase their cultural awareness.

Students will:

- engage in active Spanish conversations with classmates, guests, and traveling companions
- gain confidence to initiate and maintain a Spanish conversation with native Spanish speakers
- sharpen their public speaking skills
- practice analytical and creative writing
- write, record, highlight, reflect, and recreate their daily experiences through drawings, dialogues and skits that will wrap up the day and will create unforgettable memories
- review the basic structures of the Spanish grammar as well as identify and practice advance Spanish grammar in context

4. Major Topics covered in the Course

Through a course packet, specifically tailored to this particular course, class lectures and discussions, and on-site discoveries, students will be guided to take full advantage of a unique language opportunity.

Moreover, the Costa Rican landscape, culture, anecdotes and people will offer students the opportunity to immerse themselves in a vivid learning experience. Field trips and daily life experiences will supplement and enhance our in-class learning. Students will seek to meet local people and to learn first-hand about Costa Rica's life.

We will learn about current life in Costa Rica, its people and its natural resources. We will work on vocabulary acquisition, grammar skills, and language fluency through various tasks, including personal and creative writing and a variety of oral assessments, such as interviewing with local people and doing presentations for the class.

5. Required BEFORE departing

Acquire the Readings and Materials:

- 1) KIIS Costa Rica Course Pack (available for purchase during Orientation day.)
- 2) A espiral notebook
- 3) A couple of pens of different colors, pencils and eraser
- 4) Small diary or notepad for journaling and taking notes while out and about
- 5) English-Spanish Dictionary OR access to www.wordreference.com / www.Spanishdict.com / www.rae.es
- 6) Students may be required to pay the cost of certain cultural events and museums as well local transportation in the city. A tentative cost will be provided during orientation

Complete Prep activities

- 7) Research the assigned topic (Topics TBC by faculty during orientation or before via email)
- 8) Familiarize yourself with Costa Rica's culture and current events
- 9) Review vocabulary pertaining to nature, fauna and flora, food, pastimes

6. Graded Assignments:

- 5% Before departure (written research assignment to be turn in upon departure)
- 5% Bienvenida (oral individual introductions and mini presentations)
- 30 % Participation, Preparation and Oral engagement in class and when out and about
- 30% Daily Written and Oral Graded Assignments and Quizzes
- 20% Individual (in-situ) and Group Presentations (in-class)

10% Final Individual Written Project (insightful and creative paper) There will be no make-up opportunities and late assignments will not be accepted.

Quizzes may be given at the instructor's discretion over key points (they may or may not be announced)

The following grading scale will be used in this course: A: 90 - 100; B: 89 - 80; C: 79 - 70; D: 69 - 60; F: Below 60

Students are expected to abide by the university's guidelines regarding academic integrity. "Students who commit any act of academic dishonesty may receive from the instructor a failing grade in that portion of the coursework in which the act is detected or a failing grade in the course without possibility of withdrawal".

7. Attendance Policy:

KIIS program participants are expected to be punctual to and in attendance at all classes, presentations, meetings and required excursions, and to remain with the program for the full academic period. Unexcused absences from classes and/or mandatory meetings will result in a lowering of the student's final grade, as will excessive tardiness. Multiple unexcused absences could result in expulsion from the program. Any absence from an academic class session must be excused for medical reasons.

8. Disability Accommodation:

In some cases, you may need to make arrangements for a caregiver to join you on your KIIS program, should your physician, campus disability accommodation office, or KIIS make such a recommendation or require it.
