ART 260: Painting – Outdoors in Greece (3 hours)

1. Course Description:

ART 260: Painting – *Outdoors in Greece* is a course that will provide students with an immersive artistic experience within the dramatic landscapes of Greece. This course will primarily instruct students in the "Plein Air" tradition of drawing and painting, working from direct observation while outdoors in nature. Our subject matter will be expansive seascapes, breathtaking mountain-top vistas, shimmering cityscapes, and spectacular monuments and ruins from the ancient world. Students will be instructed in using and applying various art materials, such as graphite, charcoal, pen/ink, marker, colored pencils, and/or watercolor. Careful and thoughtful consideration will be given to composition, stylization, and process. Students will be challenged to capture and render fleeting moments in time within their sketchbooks and on an assortment of professional quality artist paper culminating in a collection of artworks that document the student's unique observations of the Greek landscape.

4. Major Topics Covered in the Course:

The content of this studio art course will provide the student with the experience of creating individual and intellectually independent artworks using water-based media that addresses personal interpretations of assigned or self-assigned themes and stated project objectives. The objective of the course is to create a body of artwork that documents one's observations and experiences of the Greek landscape.

This course will challenge:

- Technical abilities
- Perceptual acuity
- Understanding of pictorial form
- Critical thinking and verbal communication of related areas

1) **WATERCOLOR PAINT or WATERCOLOR PENCILS** (student grade is fine, but <u>not</u> scholastic) – **Recommended Brands:**

8. Attendance Policy:

KIIS program participants are expected to be punctual to and in attendance at all classes, presentations, meetings and required excursions, and to remain with the program for the full academic period.
