ART 491 Topics: Greek Art, Design, & Architecture (3 hours)

1. Course Description:

This course is open to all students/majors and will serve as an upper-level art studio elective or an upper-level general elective. A digital camera is required (most camera phones will work fine) and students must purchase art materials either prior to departure or upon arrival in Greece. There are no prerequisites for this course and no prior artmaking experience is necessary.

"Greek Art, Design & Architecture" is a studio art course that will provide students with a unique opportunity to engage with artworks, artifacts, objects, monuments, and structures in Greece through excursions and artmaking. Students will gain a basic knowledge of the symbolic and narrative meaning embedded within or projected onto these objects/structures, enabling them to understand Greek art/architecture's aesthetic value and the specific purposes for which they were created. The course will instruct students in basic technical skills using various art materials and conceptual strategies for personal artmaking. Students will observe and document examples of Greek art, design, and architecture through digital photography, sketching, and drawing. These photographic and drawn copies will serve as the basis for further creative investigation, and research and serve as the source of inspiration for more personal or expressive works of art. Completion of the course will culminate in the creation of a portfolio of artworks representative of the student's firsthand experience of Greek art and architecture.

3. Course Objectives and Learning Outcomes:

4. Major Topics Covered in the Course:

- 1) To observe, photograph, sketch/draw and research numerous works of art, design, and architecture as they exist in Greek museums, galleries, churches, and historical sites.
- To analyze and consider the context and function of these artworks, artifacts, and structures using inquiry-based thinking, information literacy, and critical thinking.
- To develop the basic skills to create images using available two-dimensional techniques and materials (watercolor, pencil, markers, charcoal, pastel, etc.) employed by designers and artists.
- 4) Class sessions and excursions will be used to investigate and photograph images as they are observed at excursion sites. Major assignments will consist of creating and presenting a research-oriented portfolio, as well as recreating images using art techniques.
- 5) Parallel to organizing a research photo archive and making art objects,

students are also required to complete assigned readings, submit informal writing assignments, present their work/research, and critique the work of classmates – all of which aligns with the "Place-As-Text" experiential learning model.

5. Required Readings and Materials:

Students must purchase art supplies either prior to travel or on-site and <u>must</u> <u>bring a digital camera with ample storage</u> (8GB SD card minimum or cloud storage) and a camera <u>USB cable</u>. Students will be expected to prepare digital presentations of their work, therefore, it is recommended to bring a laptop or tablet that will allow you to create a basic slide presentation (ie. PowerPoint, etc.). If unavailable, the professor can lend a laptop during scheduled work times at the hotel.

<u>REQUIRED ART MATERIALS & TEXTS</u> (Can be purchased in Greece or in prior to departure)

*You do not need to purchase materials you already own. It is your responsibility to replenish any materials that you run out of and need in order to complete assignments. If you come to class without materials or are unprepared to work, you will be recorded as absent.

8. Attendance Policy:
