### PSY 481: History of Psychology

#### 1. Course Description:

Overview of major historical developments in psychology and related scientific disciplines, such as medicine, neurophysiology, and physics. Emphasizes developments over the past 500 years. History of the scientific study of human/animal behavior, as well as cognitive, perceptual, and mental functioning. The critical role of the German-speaking world in the development of modern scientific psychology, its theories, and their philosophical underpinnings will especially be explored. Activities and discussion will emphasize the role of time, location, and culture on the development and adoption of ideas in the history of psychology.

#### 2. Overall KIIS Program Student Learning Outcomes:

##### KIIS Study Abroad Mission Statement:

KIIS provides high-quality education abroad programs for students from all diverse backgrounds that promote deep international learning, are integrated into the curriculum, and encourage critical and creative thinking. Our goal is to help students understand the wider world and develop personal and professional skills for lifelong enrichment. ##### Students participating on KIIS study abroad programs aim to:

- 1) Understand contemporary issues of their host country/countries (i.e. KIIS program location).
- 2) Develop skills to interact comfortably in a global setting.
- 3) Understand other cultures.

Prior to your KIIS study abroad program, and again at the conclusion of your program, KIIS will ask each student to a) answer a few multiple-choice questions, and b) write a short reflective essay (two paragraphs in length) related to the elements detailed above. There is no right or wrong answer, and your responses will not affect your grade in any way. The purpose of the exercise is to help KIIS measure the effectiveness of its study abroad programs.

### 3. Course Objectives and Specific Learning Outcomes:

The student will be able to

- A. Demonstrate an understanding of psychology in the context of its historical, philosophical, and scientific roots;
- B. Discuss the sociocultural factors that shape thoughts and ideas about human mind and human nature;
- C. Draw connections among modern systems and theories in psychology and their philosophical traditions.

### 4. Major Topics covered in the Course:

This course will involve discussion of a range of historical and modern findings and theories relevant to psychology, including

- A. Philosophies of science
- B. Empiricism and rationalism
- C. Physiology and psychophysics
- D. Structuralism and functionalism
- E. Applied psychology and the treatment of mental illness
- F. Freud and psychodynamic theory
- G. Measurement and individual differences
- H. Behaviorism
- I. Gestalt psychology
- J. Cognitive psychology
- K. Social psychology

### 5. Required Readings and Materials:

The text for this course will be Morton Hunt's *The Story of Psychology, Updated & Revised Edition* (Anchor, 2007). ISBN: 9780307278074

Additional short readings will be made available throughout the course.

### 6. Graded Assignments:

Grades will be determined by a combination of quizzes, participation/discussion activities, and writing assignments.

**Quizzes.** There will be short quizzes during most class periods that will cover material from the previous class, assigned readings, or recent field experiences. These quizzes cannot be made up if missed. However, the lowest 2 quiz grades will be dropped at the end of the course. (~40% of grade)

**Participation Activities.** Class experiences (including discussions and field experiences) will often incorporate graded activities. You are expected to complete these activities during the discussion or experiences for which they are relevant. (~40% of grade)

**Writing Assignments.** You will be asked to complete 2 writing assignments throughout the course. These papers will relate to readings, discussions, and other activities during the course. Specific details about each assignment will be provided as they are assigned. (~20% of grade)

## **7. Attendance Policy:**

KIIS program participants are expected to be punctual to and in attendance at all classes, presentations, meetings and required excursions, and to remain with the program for the full academic period. Unexcused absences from classes and/or mandatory meetings will result in a lowering of the student's final grade, as will excessive tardiness. Multiple unexcused absences could result in expulsion from the program. Any absence from an academic class session must be excused for medical reasons.

## **8. Disability Accommodation:**

KIIS will make every reasonable effort to provide accommodations for program participants with special needs or disabilities, but we cannot guarantee that we will be able to do so. Be aware that many foreign countries do not have comprehensive legislation comparable to the Americans with Disabilities Act (ADA). Please do not request accommodations directly from your KIIS Program Director or other KIIS Faculty; the KIIS Office will notify your KIIS Program Director and/or Faculty after we have received your above accommodation letter.

In some cases, you may need to make arrangements for a caregiver to join you on your KIIS program, should your physician, campus disability accommodation office, or KIIS make such a recommendation or require it.
