1. Course Description: The goal of this course is to examine cultural beliefs and practices surrounding sexual health and identity from a psychological perspective. Through analysis of historical context, cultural values and institutions, and psychological processes, we will gain an understanding of how these influences come together to shape sexual wellbeing. Paris's history of progressiveness will be illustrated through excursions that showcase past and present approaches to sexuality as a comparison point to American culture. Ideas and solutions that are sensitive to individual and cultural diversity will be discussed in response to critical issues of worldwide concern, including but not limited to discrimination, adequacy and accessibility of sexual health education and services, and the prevention of sexually transmitted infections and other sexual and reproductive health matters.

## 2. Overall KIIS Program Student Learning Outcomes:

### KIIS Study Abroad Mission Statement:

KIIS provides high-quality education abroad programs for students from all diverse backgrounds that promote deep international learning, are integrated into the curriculum, and encourage critical and creative thinking. Our goal is to help students understand the wider world and develop personal and professional skills for lifelong enrichment. ### Students participating on KIIS study abroad programs aim to:

- 1) Understand contemporary issues of their host country/countries (i.e. KIIS program location).
- 2) Develop skills to interact comfortably in a global setting.
- 3) Understand other cultures.

Prior to your KIIS study abroad program, and again at the conclusion of your program, KIIS will ask each student to a) answer a few multiple-choice questions, and b) write a short reflective essay (two paragraphs in length) related to the elements detailed above. There is no right or wrong answer, and your responses will not affect your grade in any way. The purpose of the exercise is to help KIIS measure the effectiveness of its study abroad programs.

## 3. Course Objectives and Specific Learning Outcomes:

By the completion of the course, students will be able to:

- DESCRIBE sexuality as multidimensional (i.e., biological, psychological, and social)
- IDENTIFY key developmental and societal influences on multiple aspects of sexuality, including identities, attitudes, and behaviors
- EVALUATE the roles and ethics of institutional involvement (e.g., education, medicine, government) in prescription of sexual and reproductive beliefs and practices
- CRAFT rational and sensitive ideas and solutions to current global and local sexual and reproductive matters

## 4. Major Topics covered in the Course (schedule is a work in progress and subject to change)

- Week 1 facets of sexuality, diversity, and mindful language and observation techniques

- Week 3 global and local sexual and reproductive matters
  - o Day 7 sex education (possible guest speaker/excursion)

  - o Day 9 Pigalle district excursion
- Week 4 promoting sexual well-being for all; sexual citizenship; sexual rights
  - o Day 10 sexual activism (possible guest speaker/excursion)
  - o Day 11 student led discussions
  - o Day 12 Marche des Fiertés (Paris Pride)

# 7. Attendance Policy:
