1. Course Description:

This course is a survey of the historical and cultural background of Latin America and its people from the Discovery to the present. However, this class will center in the indigenous influence in Latin American countries, particularly the Mayan culture heritage in south of Mexico and Central America. Dr. Zavala-Garrett will provide literary works short stories, poems, and essays. THE COURSE WILL BE CONDUCTED ENTIRELY IN SPANISH.

2. Overall KIIS Program Student Learning Outcomes:

KIIS Study Abroad Mission Statement:

KIIS provides high-quality education abroad programs for students from all diverse backgrounds that promote deep international learning, are integrated into the curriculum, and encourage critical and creative thinking. Students participating on KIIS study abroad programs aim to:

- 1) Understand contemporary issues of their host country (i.e. KIIS program location).
- 2) Develop skills to interact comfortably in a global setting.
- 3) Understand other cultures.

Prior to your KIIS study abroad program, and again at the conclusion of your program, KIIS will ask each student to a) answer a few multiple-choice questions, and b) write a short reflective essay (two paragraphs in length) related to the elements detailed above. There is no right or wrong answer, and your responses will not affect your grade in any way. The purpose of the exercise is to help KIIS measure the effectiveness of its study abroad programs.

3. Course Objectives and Specific Learning Outcomes:

PARTICIPACIÓN: Students enrolled in this course are expected to volunteer responses to the instructor's questions, demonstrate preparation for class by contributing to class discussions, and offering constructive comments and questions. Students are also expected to behave appropriately, showing respect to their instructor and their classmates. Class participation points are based the instructor's observation of a student's willingness to participate in the oral exercises in class, his/her full participation in the peer group work and his/her willingness to respond when called upon as well as to ask pertinent questions and make meaningful contributions to the class.

TRABAJOS EN CLASE Y ACTIVIDADES ESPECIALES: Students will be constantly working in and outside the class with different activities in order to help in their acquisition of the material covered in class. Students are expected to hand in homework ON TIME and LATE HOMEWORK WILL NOT BE ACCEPTED. Any missed in class work will automatically result in a zero for the student, UNLESS THE STUDENT HAS MISSED CLASS BECAUSE OF JUSTIFIABLE REASONS AND HAS NOTIFIED MS. CHAPA (Mérida's liaison officer) AND MYSELF ABOUT IT.

EXCURSIONES, REPORTES & NOTICIAS: Through this kind of tasks, the students will be able to share some aspects of their own experiences in the target culture reinforcing vocabulary and developing their oral skills. They will also get immersed into the local news, and they will be able select, analyze and communicate culturally relevant ideas to their classmates in the target language. For each cultural trip or excursion, students must write a report in Spanish with a personal opinion about it since they would share this information in class. Each activity from the official calendar is connected with your syllabus course. In addition, Dr. Zavala-Garrett will organize extracurricular activities reinforcing class assessments.

EXPECTATIVAS: Students are expected to come to class prepared, to thoughtfully contribute to class activities, to the responsibility of the student to find out what was covered and to learn the appropriate material. Please refer to the attendance portion of this syllabus to review the attendance policy. Students can expect the instructor to come to class well-prepared, to be available during office hours (or by appointment) and to return graded materials as promptly as possible. Daily classes will be designed so that students hear and use Spanish exclusively. Using only Spanish in class is fundamental because it is essential to your progress in mastering your Spanish skills.

NOTA: 1) Frecuentemente se compartirá una <u>noticia local o nacional de México</u> con las compañeras y la profesora. 2) Se escribirá un breve reporte escrito a mano, doble espacio de las excursiones durante el viaje para comentar en clase y entregarlo a la profesora. 3) Al final del

curso, se harán <u>presentaciones orales sobre sus experiencias personales en conexión con la</u> cultura y vocabulario aprendidos durante el programa.
