1. Course Description:

In MUS 327, we survey the history of western classical music from 1750 to around 2024. The course focuses on individual composers and their roles in developing the music of this century in the classical, and romantic eras, including some of the greatest composers in history: Haydn, Mozart, Beethoven, Schubert. Chopin, Schumann, Liszt, Brahms, Wagner, Mahler, Strauss, Stravinsky, Bartók, and many more! Many of them have strong Austrian roots and spent much of their lives in Vienna.

2. Overall KIIS Program Student Learning Outcomes:

Before your KIIS study abroad program, and again at the program's conclusion, KIIS will ask each student to a) answer a few multiple-choice questions and b) write a short reflective essay (two paragraphs in length) related to the elements detailed above. There is no right or wrong answer, and your responses will not affect your grade in any way. The exercise aims to help KIIS measure the effectiveness of its study abroad programs.

3. Course Objectives and Specific Learning Outcomes:

1. Gain a broad perspective of Western classical music from 1750 to 2024, including biographical, historical, and theoretical information on influential composers and their major works.

- 2. Understand the development of musical styles, terminology (vocabulary!), genres, and compositional procedures and their relevance to other eras and repertories.
- 3. Think critically about classical music and discover its significant sources of historical, analytical, and stylistic information.
- 4. Discover and deepen knowledge of the landmarks in music history from Mozart to Mahler, Stravinsky to John Adams.
- 5. Learn listen attentively and critically to classical music. In short, to enjoy and appreciate the wonder and variety of music during these years.

Several excursions and performances in Salzburg and Vienna provide students with opportunities that form a critical part of the course. Students will write a 200-word minimum report for each event.

Students must meet all due dates because the summer session is so concentrated. I will accept late work only under the most extreme circumstances. Students must email me in advance of any missed classes or deadlines when possible.

8. Attendance Policy:
