BIO 475 Special Topics: Tropical Biodiversity and Conservation

Course Description: This course introduces students to the extraordinary variety of plants, animals, and ecosystems of tropical regions. Students will observe and study the wide range of habitats and species in the natural regions of Costa Rica. Habitats to be visited vary from montane, valley, marine, and cultivation areas such as Arenal Volcano National Park, La Paz Waterfall Natural Park, National Park in Pacific Coast, Butterfly Farm, and Coffee, Sugarcane, and regional fruit or vegetable plantations. Emphasis is on understanding biodiversity issues in the tropics and on conservation strategies needed to protect these dwindling resources.

Prior to your KIIS study abroad program, and again at the conclusion of your program, KIIS will ask each student to a) answer a few multiple-choice questions, and b) write a short reflective essay (two paragraphs in length) related to the elements detailed above. There is no right or wrong answer, and your responses will not affect your grade in any way. The purpose of the exercise is to help KIIS measure the effectiveness of its study abroad programs.

Course Objectives and Specific Learning Outcomes: Upon successful completion of this course, students will be able to:

- Apply ecological and evolutionary theory to the biodiversity patterns observed in Costa Rica.
- Compare and contrast the biogeography and species richness of the biomes and ecosystems in Costa Rica.
- Gain confidence in abilities to explore new places and concepts.
- Evaluate and prioritize conservation programs.
- Identify common flora and fauna of Costa Rica.
- Explore the importance of indigenous ecotourism and sustainable development.

Major Topics covered in the Course: This course will cover basic principles of biodiversity, tropical ecology, and conservation.

Attendance Policy:

KIIS program participants are expected to be punctual to and in attendance at all classes, presentations, meetings and required excursions, and to remain with the program for the full academic period.
