All KIIS employees must report information they have about alleged or possible sexual misconduct/assault involving student.to-student concerns and concerns involving, but not limited to, employee-to-student, employee-to-employee, and student-to-employee to the KIIS Executive Director, KIIS Assistant Director, Ena Demir, or Michael Crowe within 24 hours of receiving such information.
